

## CLIENT AGREEMENT DAYCARE/OVERNIGHT/GROOMING

This is an Agreement between Electric City Stay & Play, LLC ("ECSP") and the pet ("pet" or "guest") owner ("Owner"). Electric City Stay & Play, LLC agrees to exercise due and reasonable care and responsible precautions against illness, injury, escape or death of all guests. The services provided are done so with without liability for loss or damage. Due diligence and care have been exercised.

Vaccines: All dogs must remain current on rabies, distemper and bordetella vaccines. All cats must be current on rabies and distemper vaccines. Proof of these vaccines must be provided by the owner prior to the guest being admitted to Electric City Stay&Play for any reason. If documentation of the required vaccines is not provided and cannot be obtained through verbal communication with the owner's veterinarian, then Electric City Animal Clinic, PC will administer these services at the expense of the client. Any variation from the required vaccines must be documented by the owner's veterinarian and any associated risks are assumed by the owner. Pets that are so young that they have not completed their entire series of vaccinations may not yet be protected and the Owner accepts risk of illness. Health: All guests must be free from any condition that could potentially jeopardize the health of other dogs or people. ECSP will isolate any pet with signs of communicable illness and will call the owner for immediate pick up or transfer to Electric City Animal Clinic, PC. All guests must be free of fleas and will be checked by ECSP staff. Immediate treatment will be required for fleas at the owner's expense. Injury/Illness: Owner understands that although all guests are supervised, that incidents of injuries may occur which include but are not limited to bites, scrapes, scratches and sprains. In the case of injury or illness, ECSP reserves the right to administer aid and to render care by the attending veterinarian from Electric City Animal Clinic, PC. Any expenses incurred, shall be the responsibility of the Owner. Vaccines are no guarantee for all communicable illnesses and there is a small risk that their pet may contract a contagious disease or illness while staying at ECSP

**Boarding Services** are charged for by the day. All guests pay for the full day of check-in. Guests that check out before 12:30pm will not be charged for that day, any guest checked out after 12:30pm will be charged for a full day of boarding. Saturday check-in and check-out is from 7am-12:30pm. Sunday check out is from 4-5pm. All guests are charged for the full day of boarding on Sunday.

**Payment:** Owner agrees to pay for all services provided at the rate in effect on the date the pet is checked in to ECSP for overnight boarding, daycare or grooming. Owner further agrees to pay all costs and charges for special services requested and all veterinary costs for the pet during the period the pet is in the care of ECSP. All ECSP prices are subject to change.

**Refusal:** ECSP reserves the right to deny admittance to any pet or to dismiss any pet for any reason at any time. The determination shall be made at the sole discretion of ECSP.

**Photos:** Numerous pictures are taken of guests playing at Electric City Stay and Play. Pictures may be posted to our website, social media in promotional materials at no compensation to the owner.

**Personal Belongings:** Personal items are left at Owner's own risk. ECSP will not be responsible or liable for lost, stolen or damaged personal items left with the Owner's pet(s) including but not limited to leashes, collars, toys and bedding.

**Authorized Agents:** The Owner represents that they are the legal owner of the pet described in their Admission Form, free and clear of all liens and encumbrances.

By signing this agreement, the Owner acknowledges understanding and acceptance of this agreement in its entirety and will remain valid anytime the Owner's pet(s) are in the care of ECSP for any reason. Owner's name (Please Print):
